

TOWN OF DALE

ORDINANCE 2:15

ALL –TERRAIN/UTILITY TERRAIN VEHICLES & ROUTES, TOWN OF DALE, OUTAGAMIE COUNTY, WISCONSIN

The Town of Dale, Outagamie County, Wisconsin ordains as follows:

SECTION 1: INTENT

The Town of Dale, Outagamie County, Wisconsin hereby adopts the following All-Terrain Vehicle (ATV) and Utility Terrain Vehicle (UTV) upon roadways listed in Section 3. In due consideration of recreational value to connect trail opportunities and weighted against possible dangers, public health, liability aspects, terrain involved, traffic density and automobile traffic volume, this route (S) has been created.

SECTION 2: STATUTORY AUTHORITY:

This route (S) is created pursuant to township authority as authorized by 23.33(8)(b) Wis. Stats. The applicable provisions of 23.33 Regulating ATV/UTV operations pursuant to routes and trails are adopted.

SECTION 3: ROUTES AND TRAILS:

- A. The Town of Dale reserves the right to close or modify routes and trails at any time. Any restrictions of trails and routes shall be designated by a motion and by majority of the Town of Dale Town Board and shall be marked accordingly.
- B. The Town of Dale or its designee shall maintain all routes and trails signs within the Township.
- C. All ATV/UTV routes and trails shall be signed in accordance with NR64.12(7)(c).
- D. All township roads, sidewalks, alleyways and transportation marked corridors within the Town of Dale are hereby designated as ATV/UTV routes. Authorized private land subject to public easement or leases are designated trails. All county roadways located in the Town of Dale are hereby declared ATV/UTV routes if authorized by the County of Outagamie.
- E. The Town of Dale shall maintain a route and trail map.

SECTION 4: CONDITIONS

- A. All ATV/UTV operators on routes shall observe posted roadway speed limits; not to exceed 35 MPH.
- B. All ATV/UTV operators shall ride single file.
- C. ATV/UTV operators shall observe all laws of the State of Wisconsin pertaining to the use and operation of an ATV/UTV.

SECTION 5: ENFORCEMENT:

This ordinance shall be enforced by any law enforcement officer authorized to enforce the laws in the State of Wisconsin.

SECTION 6: PENALTIES

Wisconsin State ATV/UTV Penalties are found in Section 23.33(13)(a) Wis. Stats. or any amendments thereto are adopted by reference.

SECTION 7: SEVERABILITY:

The provisions of this ordinance shall be deemed severable and it is expressly declared that the Town of Dale would have passed the other provisions of this ordinance irrespective of whether or not one or more provision may be declared invalid. If any provision of this ordinance or the application to any such person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to the other person’s circumstances shall not be effected.

SECTION 8 EFFECTIVE DATE:

This Ordinance shall be effective upon passage and publication as provided by law.
